Entry Guidelines - For Windham County Artists, 18 and Older

ELIGIBILITY

Entries must be original and must have been executed solely by the person in whose name they are submitted. Each artist may submit a maximum of 6 (six) entries, while a maximum of 3 (three) entries may be chosen by selection jurors. Entries will be accepted in the following categories: Painting, Photography and Sculpture. Any incomplete application, fee, or images that are not labeled or formatted correctly or are of poor quality will be returned to the artist and will not be eligible for entry. All final entries must be completely assembled, and/or framed, and ready for display, as recommended by each jurer.

ENTRY

Each artist may submit a maximum of six entries, with a maximum of three being eligible for selection. Images, application form and entry fees must be postmarked May 1, 2009. Application form must be signed. Entry fee is not refundable. A self addressed stamped envelope must be included with your application for notification of acceptance, or you may choose to be notified by email. ENTRY LABELING

Preliminary judging of entries will be done from digital images photos or slides. Digital images submitted must be 300 dpi, with largest dimension no larger than 6", in jpeg format. Please name files as follows:

The jurors have the option, upon receipt of the preselected work, to reject any works not commensurate with submitted images.

NOTIFICATION OF ACCEPTANCE

Mailed notification of acceptance to the Newfane Fine Art Show will be postmarked by June 26th 2009.

DELIVERY OF ACCEPTED WORK

Artworks selected for the Newfane Fine Art Show will be received on August 7th, 2009. Please deliver between the hours of 9am-12pm this day at the **Newfane Union Hall**, at West Street in Newfane, VT 05345. Please make any other arrangements by email: newfaneart@gmail.com, or phone

Display will be at the discretion of the Newfane Business Association Art Committee.

SALES

A commission of 20% will be charged on all sales. All proceeds will benefit the Newfane Business Association. All work purchased must be removed by end of exhibit or arrangements must be made with artist.

LIABILITY

Liability and insurance on artwork are total responsibility of the artist.

PICK UP OF ARTWORK

Awards will be given in each category:

Painting, Photography and Sculpture
1st, 2nd & 3rd
Honorable mentions may be awarded at the jurors discretion.
